INVITATION FOR TENDERS

Project: Reconstruction of outdoor lighting system of Ternopil city "Lighting without mercury"

Department of Housing and Utilities, Municipal Improvement and Ecology of Ternopil City Council, hereinafter referred to as "the Employer", intends to use part of the proceeds of a loan and grant from the Nordic Environment Finance Corporation (NEFCO) towards the (cost) of Reconstruction of outdoor lighting system Ternopil city "Light without mercury".

The Employer now invites the Contractors to submit their tenders for the following contract to be funded by the the loan and grant, aimed at purchase of:

"Development of the Design documentation, supply and installation of all necessary equipment for replacement of the existing fixtures with LED ones, replacement of mental brackets, reinforced concrete poles, suspension of SIW wire using fittings for its suspension, replacement and modernization of control cubicles, disposal of dismantled lamps, as well as dismantling of all outdated electrical equipment".

To be qualified for the award of a Contract, Tenderers must satisfy the following minimum criteria:

- the Tenderer, has the financial, technical and production capability and capacity necessary to perform the Contract, and Tenderer's average annual revenue in the previous **three** years was at least **two** times greater than price of his tender. In case of tender submitted by JVCA, the leading partner should demonstrate at least 50% compliance with the requirement;
- the Tenderer has satisfactorily delivered similar plant and works to other Employers and completed at least **five(5)** similar Contracts in the recent **five** years;
- the Tenderer or its agent will be able to carry out warranty obligations;
- the Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;
- in the case of a Tenderer offering to deliver plant under the Contract which the Tenderer does not manufacture or otherwise produce, the Tenderer has been duly authorised by the plant's manufacturer or producer to deliver the plants in the Employer's country.

In preparation of their offers, the Tenderer should take into account that the works in this Contract will tentatively start on May 2020 and continue to October 2020.

Tender documents, upon request from prospective Tenderer, will be sent by email free of charge in electronic format (PDF file). If requested to send documents in the written form, the documents will be sent by Employer to Tenderer on terms and conditions agreed by the two.

All Tenders must be accompanied by a Tender security in the form of tender-securing declaration whose form is provided in Tender Document. The purpose of Tender security is to ensure the Tenderers are serious about their participation.

The winning tenderer will have to provide performance security from a reputable bank acceptable to NEFCO. The Contract Performance Guarantee is 5% of the Contract cost.

Tenders must be delivered to the office at the address below before 23.03.2020 at 13:00 p.m., at which time they will be opened in the presence of those Tenderers' representatives who choose to attend.

Pre-tender meeting of Tenderers with the Employer's representatives for visiting the project sites and discussion of technical and logistical issues will be held on 17.02.2020 at 13:00 p.m. at the address: Ternopil city, Kopernyka str., 1, (1st floor), Resource Centre of ACAB Support on Clean Energy.
