In order to assess the qualifications and competence of the consultants seeking to be shortlisted, the information submitted should include the following:

For individual consultants

- Statement of interest and availability to work on the assignment including description of current work schedule and forecast for next 24 months.
- CV with details of experience in similar assignments, including their locations (especially assignments in Ukraine, alternatively, references from other countries in the region such as Russia, Belarus or other CIS countries

The above information should not exceed 15 pages, including CVs.

For Firms

- Company profile, organization and staffing for the assignment;
- Details of experience in similar assignments in Ukraine, including their locations, alternatively, references from other countries in the region such as Russia or Belarus; and
- CVs of key experts available to work on the assignment.

The above information should not exceed 10 pages, excluding CVs.

Consultant Profile: When expressing an interest for shortlisting the consultant should take into consideration the following general profile demands and requirements:

The consultant should have experience from internationally financed projects and of water and waste water projects.

NEFCO seeks to shortlist consultant with the following profiles:

- Senior Technical adviser (International Expert, Technical lead Water programme) with at least 20 years of comprehensive experience in managing assignments within the Water Sector in EU/CIS countries;
- Technical Expert Water engineer, International Expert with at least 15 years of expertise in water and waste water projects, Ukrainian and/or Russian language skills are considered as advantage.;
- International expert Wastewater Process Specialist with at least 15 years of expertise in process design and operation of wastewater treatment plants in EU/CIS countries within the Water Sector.

Firms or Individual consultants - framework contract

- Supervisor for Civil Works with at least 10 years of expertise in industrial and/or in water and wastewater projects in Ukraine. English language competence is required.
- Supervisor for Mechanical Works with at least 10 years of expertise in industrial and/or in water and wastewater projects in Ukraine. English language competence is required.
- Electrical and Automation Engineer with at least 10 years of expertise in industrial and/or in water and wastewater projects in Ukraine. English language competence is required.
- Supervisor for Electrical and Automation Works with at least 10 years of expertise in industrial and/or in water and wastewater projects in Ukraine. English language competence is required.

Next steps: Based on the documentation received, NEFCO will prepare a shortlist of qualified consultants. NEFCO will also be responsible for the possible procurement and contracting of the consulting services in question.

The preliminary time line is as follows: NEFCO will evaluate and rank the shortlisted consultants after the submission deadline and invite the highest ranked consultant for each assignment to submit a proposal in May 2020. The first assignments are expected to start in June 2020.
