The Department of Capital Construction of the Executive committee of Ivano-Frankivsk city council is going to continue to announce competitive tendering for the works, goods and services defined by the Project “Energy efficiency improvements in public buildings in the city of Ivano-Frankivsk” (1st and 2nd stage). Tendering for the contracts are planned to continue in the first quarter of 2019.

The Department of Capital Construction of the Executive committee of Ivano-Frankivsk city council intends to use the funds from a loan provided by Nordic Environment Finance Corporation (NEFCO), funding from the city of Ivano-Frankivsk and grant funds from Eastern Europe Energy Efficiency and Environment Partnership (E5P)* for the works, goods and services as listed below.

The Projects is being implemented based on the decision No.39-2 of the Ivano-Frankivsk city council dated 22 December 2015 “On attracting the loan facility from NEFCO for financing the Project “Energy efficiency improvements in public buildings in the city of Ivano-Frankivsk” and decision No. 22-11 dated 15 March 2017 “On attracting the loan facility from NEFCO for financing the Project “Energy efficiency improvements in public buildings in the city of Ivano-Frankivsk” (2nd stage).

As a part of continuation of the “Energy efficiency improvements in public buildings in the city of Ivano-Frankivsk” project (1st stage) and within the framework of the “Energy efficiency improvements in public buildings in the city of Ivano-Frankivsk” project (2nd stage) in 2019 contractors will be selected for implementation of contracts in a number of up to 20, in a total amount of about 108 million UAH (about 4 million Euro) in the following areas:

- thermal modernization of the public buildings;
- partial replacement of the windows and entrance doors;
- partial replacement of the cooking stoves;
- partial replacement of the incandescent light bulbs for the LED bulbs;
- reconstruction of the heating systems;
- balancing of the heating system;
- installation of individual heating substations with automated control;
- installation of the local ventilation systems with heat regeneration.
