## INVITATION FOR TENDERS

Festelita Village Local Council hereinafter referred to as “the Employer”, intends to use part of the proceeds of a loan from the Nordic Environment Finance Corporation (NEFCO) towards the cost of streetlight reconstruction in Festelita Village, Stefan Voda District.

The Employer now invites tenders from Contractors for the following contract to be funded from part of the proceeds of the loan:

*Supply and installation of all required electrical and technical equipment to extend the streetlighting in Festelita Village, Stefan Voda district – replacement of 100 existing lighting fixtures with predominantly mercury lamps by new LED fixtures on 6 km of worn out wiring by self-supporting insulated wiring and extension of the streetlighting networks with approx. 5,1 km of self-supporting insulated wire (hanging of 11,1 km in total), install additional 200 LED lamps (300 in total);*

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- the Tenderer has the financial, technical and production capability and capacity necessary to perform the Contract, and Tenderer’s average annual revenue in the previous **three years (3)** was at least **two** times greater than price of his tender. In case of tender submitted by JVCA, the leading partner should demonstrate at least 50% compliance with the requirement;
- the Tenderer has satisfactorily supplied similar plant and works to other purchasers and completed at least **three (3)** similar contracts in the recent **five** years, each of the value at least 50% of the proposed price of his Tender;
- the Tenderer or its agent will be able to carry out warranty obligations;
- the Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;

Tender documents, upon request from prospective tenderer, will be sent by email free of charge in electronic format (PDF file). If requested, the documents will be sent by Employer to Tenderer on terms and conditions agreed by the two.

All tenders must be accompanied by a tender security in the in the form of tender-securing declaration whose form is provided in Tender Document. The purpose of tender security is to ensure the tenderers are serious about their participation, irrespective of the contract size.

Tenders must be delivered to the office at the address: **Festelita Village Mayoralty, 9 Ștefan cel Mare street, Stefan-Voda District, Festelita village, MD-4220, Republic of Moldova** , on or before **11.08.2020 at 11:00 (Chisinau time)**, at which time they will be opened in the presence of those tenderers’ representatives who choose to attend.

All potential tenderers that solicited the tender documents can request a visit to the project site. After the solicitations received, the dates and the hour of the visit will be coordinated in advance with each tenderer.
