# Conversion of Refrigerating Equipment of LLC «Fishing company «Polar Sea+» Procurement of Plant and Related Works.

Limited liability company «Fishing company «Polar Sea+» (LLC «Fishing company «Polar Sea+») hereinafter referred to as "the Employer", intends to use part of the proceeds of the Grant from the Arctic Council Project Support Instrument (PSI) through Nordic Environment Finance Corporation (NEFCO) towards the cost the conversion of the Employer's refrigerating equipment to reduce harmful emissions to the ozone layer of the atmosphere. The funding is dependent on availability of PSI funds under financing agreements to be entered into. Project is implemented within the framework of the Arctic Council project called "Phase-out of Fluorinated Greenhouse Gases and Ozone-Depleting Substances at Fish and Seafood Processing Enterprises of the Murmansk Oblast (Arctic Zone of the Russian Federation). Phase 2".

The tender is conducted in accordance with the NEFCO Procurement Guidelines.

The Employer now invites sealed tenders from Contractors for the following contract to be funded from part of the proceeds of the Grant:

Term of delivery of goods, performance of works, rendering of services: In accordance with the requirements of the Employer (section IV "Employer's requirements").

Place of delivery of goods, performance of works, rendering of services: 184376, 150 b Minkino village, Kola district, Murmansk region, Russian Federation

#### Scope of deliveries, works, and services:

- 1. development of design estimates for conversion of the Employer to ozone- and climatesafe substances and technologies;
- 2. purchase, production and supply of primary and extra equipment;
- 3. installation, commissioning and other works according to the design estimates;
- 4. purchase, installation, commissioning of safety equipment and taking of safety measures;
- 5. obtaining of permits;
- 6. recovery of ODS and F-gases for destruction or recycling;
- 7. dismantling and disposing of old equipment;
- 8. improvement of energy efficiency

9. training of enterprise's personnel in issues of environmental legislation and operation of environmentally safe refrigeration equipment in accordance with the law of the Russian Federation.

The offer of partial delivery of goods, works and services is not allowed.

The form and all terms of the draft Agreement (section IV "Employer's requirements") are mandatory. Optional offers by the tenderers are not allowed.

The contract price has to include all expenses related to the performance of the contract specified in the draft Agreement (section IV "Employer's requirements").

### **Requirements to tender participants**

Tendering for contracts that are to be financed with the proceeds of the Grant is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- 1. The tenderer shall demonstrate that it has access to or has available liquid assets, unsecured real assets, credit lines and other financial means to meet the working capital requirements for the performance of the contract for an amount not less than the value of its tender, taking into account the tenderer's obligations under other contracts.
- 2. The average annual income for the period 2017-2019 must be at least 120% of the value of the Tenderer's tender.
- 3. The tenderer shall demonstrate that it has experience in implementing projects for the construction of refrigeration systems for fish processing enterprises and/or fishing & fish processing vessels of the fisheries complex, for which work has been performed on the installation, repair and/or maintenance of industrial refrigeration units and air conditioning systems and / or projects for working with natural refrigerants, including ammonia, carbon dioxide, hydrocarbon refrigerants. The tenderer shell have experience in implementing refrigeration systems in the Arctic zone of the Russian Federation. As a confirmation of this experience, the tenderer submits information about the concluded contracts for the performance of the above (or similar) works for the period 2017-2020 as part of its tender offer. The minimum number of contracts is three (3) each for the amount of at least 70% of the value of the Tenderer's tender.
- 4. All tenders must be accompanied by a tender security in a form of a Declaration of the tender guarantee. Any offer that is not accompanied by a Declaration of the tender guarantee will be rejected by the Employer as inappropriate.

Tender documents can be obtained from the office at the address below free of charge upon a written request from a prospective Tenderer.

Upon receiving the written request from prospective Tenderer, the documents will be promptly dispatched electronically in PDF and MS Word format, however, no liability can be accepted for their non-delivery or late delivery. In case of discrepancies between the PDF and Word versions of the document, the PDF version shall prevail. Similarly, in case of discrepancies between the English and Russian versions of Tender documents the English version will prevail.

Tenders must be delivered to the office at the address below on or before **20th May 2021, 11:00 Moscow time**, at which time they will be opened in the presence of those tenderers' representatives, who choose to attend.
