Development of design documentation, including passing the expertise, conducting designer's supervision, as well as the supply of materials and execution of works for the “Thorough repair of the building of the Pediatric Department of the MNE “Shchastya City Hospital of the Shchastya City Military-Civil Administration of Shchastya district, Luhansk region”, at the address: Donetska str., 97, Shchastya city, Luhansk region

This Invitation for Tenders follows the General Procurement Notice for this project which was published on the the Procurement Notices section of NEFCO’s website (<https://www.nefco.int/procurements/>) on March 22, 2021.

Shchastya City Military-Civil Administration of Shchastya district, Luhansk region hereinafter referred to as “the Employer”, intends to use part of the proceeds of financing from the Nordic Environment Finance Corporation (NEFCO) towards the cost of “*Thorough repair of the building of the Pediatric Department of the MNE “Shchastya City Hospital of the Shchastya City Military-Civil Administration of Shchastya district, Luhansk region”, at the address: Donetska str., 97, Shchastya city, Luhansk region*”.

The Employer now invites sealed tenders from Contractors for the following contract to be funded by NEFCO costs aimed at procurement of: *development of design documentation, including passing the expertise, conducting designer's supervision, as well as the supply of materials and execution of works for the “Thorough repair of the building of the Pediatric Department of the MNE “Shchastya City Hospital of the Shchastya City Military-Civil Administration of Shchastya district, Luhansk region”, at the address: Donetska str., 97, Shchastya city, Luhansk region*.

Preliminary main scopes of works planned for implementation: wall insulation area – 1,150 m², socle insulation area - 235 m², installation of the blind area - 212 l.m., door replacement - 23.4 m², overlap insulation – 1,020 m², replacement of external heating network - 70 l.m., installation of individual heating system - 1 unit, replacement of radiators - 30 units, replacement of heating pipes - 196 l.m., replacement of fixtures - 156 units, laying of internal electrical networks – 1,100 l.m.

Tendering for contracts that are to be financed with the proceeds of NEFCO financing is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- the Tenderer, has the financial, technical and production capability and capacity necessary to perform the Contract. The Tenderer demonstrates the revenue for each previous three years and the average annual revenue in the previous 3 (three) years should be at least 2 (two) times greater than price of his tender. In case of tender submitted by JVCA, the leading partner should demonstrate at least 50% compliance with the requirement;
- the Tenderer has successfully supplied similar plant and works to other purchasers and successfully completed at least five (5) similar contracts by scope and cost (the scope of such a contract must be at least 5 million UAH) in the recent 5 (five) years. In case of tender submitted by JVCA, the leading partner should demonstrate at least 3 (three) own contracts;
- the Tenderer will be able to carry out warranty obligations;
- the Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;
- in the case of a Tenderer offering to supply plant which the Tenderer does not manufacture, the Tenderer have to certify that he has been duly authorised by the Manufacturer to supply the plant in the Purchaser’s country.

When preparing the tender offer, the Tenderer should take into account that the works in this contract will tentatively start in **September 2021** and should be completed **October 2022**.

Tender documents may be obtained from the office at the address below free of charge upon a written request from a prospective Tenderer.

Upon receiving the written request from prospective Tenderer, the documents will be promptly dispatched electronically in PDF and MS Word format, however, no liability can be accepted for their non-delivery or late delivery. In case of discrepancies between the PDF and Word versions of the document, the PDF version shall prevail.

All tenders must be accompanied by a Tender-Securing Declaration.

Tenders must be delivered to the office at the address below on or before **July 05, 2021 at 10:00 a.m.**, at which time they will be opened in the presence of those tenderers' representatives who choose to attend.

Pre-tender meeting for Tenderers with representatives of the Employer for visiting the project site and discussion of technical and procedural issues will be held on around **May 27, 2021 at 11:00 a.m.** at the address: **Myru square, 9, Shchastya city, Shchastya district, Luhansk region, 91480.**
