This Invitation for Tenders follows the General Procurement Notice for this project which was published on the Procurement Notices section of NEFCO's website (https://www.nefco.int).

Department of education, youth and sports of Chortkiv City Council hereinafter referred to as "the Employer", intends to use part of the proceeds of financing from the Nordic Environment Finance Corporation (NEFCO) towards the cost of "Energy Efficiency measures in Chortkiv City, Ukraine" project.

The Employer now invites sealed tenders from Contractors for the following contracts to be funded by NEFCO:

- CHORTKIV Lot 1: Loan financed equipment and related works for major repair with implementation of energy efficient measures for buildings of Chortkiv School No.7 (I-III degrees) of Chortkiv city council, at the following address: 25 Shevchenka St., Chortkiv City, Ternopil region;
- CHORTKIV Lot 2: Grant financed equipment and related works for major repair with implementation of energy efficient measures for buildings of Chortkiv School No.7 (I-III degrees) of Chortkiv city council, at the following address: 25 Shevchenka St., Chortkiv City, Ternopil region.

In the frames of major repair, the Employer intends to implement such energy efficiency measures as thermal insulation of walls and roof, replacement of doors, replacement of building heating system, installation of heat pump for hot water preparation as well as other supporting works.

Tenders are invited for both lots: tenders only for one lot will be rejected. Value added tax (VAT) exemption procedure is foreseen for equipment supplied under Lot 2.

Tendering for contracts that are to be financed with the proceeds of NEFCO financing is open to firms/individuals from any country.

To be qualified for the award of a contract, tenderers should have the human resources and technical capacity to perform these works and must satisfy the following minimum criteria:

- a) Average annual turnover over the last 3 (three) years (2018-2020) years exceeded:
 - for CHORTKIV Lot 1 and Lot 2 combined: 40 000 000 UAH;
- b) The Tenderer shall demonstrate that it has access to, or has available, liquid assets, unencum-bered real assets, lines of credit, and other financial means sufficient to meet the production cash flow for the contract, estimated as not less than 20% from his tender proposal for both lots combined,
- c) Experience as Contractor, in at least 5 (five) contracts within the last 5 (five) years, with total value exceeded:
 - for CHORTKIV Lot 1 and Lot 2 combined: 50 000 000 UAH:

that have been successfully and substantially completed and that are similar to the scope of the proposed Equipment and Related Works.

- d) In case of a tender submitted by JVCA, the leading partner should demonstrate at least 60% compliance with the requirements (a) (b) (c) above;
- e) Non-performance of contract by Tenderer (including members of JVCA, if appropriate) did not occur during the last **3 years**;

f) All pending litigation against Tenderer (including members of JVCA, if appropriate) shall in total not represent **more than 30%** of the Tenderer's net asset value;

Tender documents may be obtained from the office at the address below free of charge upon a written request from a prospective Tenderer.

Upon receiving the written request from prospective Tenderer, the documents will be promptly dispatched electronically in PDF and MS Word format, however, no liability can be accepted for their non-delivery or late delivery. In case of discrepancies between the PDF and Word versions of the document, the PDF version shall prevail.

All tenders must be accompanied by a Tender-Securing Declaration.

Tenders must be delivered to the office at the address below on or before 01, November 2021, at which time they will be opened in the presence of those tenderers' representatives who choose to attend.
