Project name: Improving the energy efficiency of public buildings of Slavutych city

Slavutych City Council, Ukraine, intends using the proceeds of a loan from Nordic Environment Finance Corporation (NEFCO), grant from Neighbourhood Investment Platform of the European Union (NIP) and funding from the city, towards the costs of a project aimed at improvement of energy efficiency of public buildings in Slavutych city.

The Project foresees implementation of energy-efficient measures at 2 educational buildings, namely thermal modernization of Kindergarten "Children Development Center" in Vilniuskiy quarter, 1 and thermal modernization of the sports and recreation complex "Bogatyry" in Belgorodskiy quarter, 1 in Slavutych city, which characterized by high thermal and electrical energy consumption. The Project will result in reduction of energy consumption and CO₂ emissions as well as budgetary expenditures savings. Also, it is of great social importance since implementation of the project will improve the quality and conditions of education services and will extend lifetime of the buildings.

The Project is a sub-project of the NIP II Ukraine Energy Efficiency in Small & United Municipalities Programme with a total investment of about 13 mln EUR for projects in 12 municipalities in Ukraine.

The Project, which has the total estimated cost of approximately 1.45 mln. EUR (including loan and grant funds as well as local co-funding), will require the procurement of the following works, goods, and services for implementation of energy efficiency measures in educational buildings of Slavutych city:

- Thermal insulation of walls and socle;
- Thermal insulation of flat roof;
- Windows and doors replacement;
- Modernization of ventilation and lighting systems;
- Modernization of heating and engineering systems, etc.
- Installation of heat pump for hot water needs
- Installation of solar power plants and solar collectors for domestic hot water.

Tendering is expected to begin in the first quarter of 2022.

Contracts to be financed with the proceeds of a loan and grant from NEFCO will be open to companies from any country and will be subject to the NEFCO Procurement Policy and Procedures available at:
