The municipalities of Ivano-Frankivsk, Ternopil, Khmelnytskyi, Novovolynsk and Nemishaeve represented by Project Implementation Units (PIU) in each municipality are **planning to announce a series of competitive tendering** for the works, goods and services defined by the Project "Housing for internally displaced persons (IDPs) and rehabilitation of liberated cities in Ukraine, Component II". Tendering for the contracts for each municipality is planned to begin in July, 2023.

The municipalities intend to use the funds from grants provided by the European Union (EU) and funding from the respective municipality for the works, goods and services as listed below.

Within the framework of the project "Housing for internally displaced persons (IDPs) and recovery of liberated cities in Ukraine, Component II", contractors will be selected in 2023 for implementation of contracts in a total amount of about EUR 35,5 million in the following areas:

- Construction of fully equipped and furnished blocks of flats with useful area between 5,000 square meters and 7,000 square meters and with 3-5 floors in the municipalities of
 - Ivano-Frankivsk, planned investment EUR 9.5 million;
 - Ternopil, planned investment EUR 9.5 million;
 - Khmelnytskyi, planned investment EUR 8.4 million;
 - Novovolynsk, planned investment EUR 7.1 million.
- Capital repair of the building of the Communal non-profit enterprise "Center for

Primary Health Care of Nemishaeve Settlement Council", which is a health care institution in the community:

- Nemishaeve, planned investment EUR 911,112.58

Contractors are encouraged to express their interest in the procurement by, as soon as possible, but not later than June 30, 2023*, sending e-mail to the Project Management Consultant at idp2.ua@ic-group.org

It is explicitly noted that:

- the non-provision of information does not exclude any company from participating in the tender process
- the final criteria to bidders will be set in compliance with NEFCO rules and
- companies who miss / do not express their interest shall not be excluded from tendering.
