- introduction of particular measures to improve energy efficiency in residential and public building connected to DH networks of Lutskteplo; the measures may include both low-cost measures (like adjusting automatic controls) and more expensive retrofits of building-internal heating systems; the final list of measures shall be specified at a later stage of Project implementation.

Lutskteplo therefore announces competitive tendering for the works, goods and services defined by the above-named project and listed below.

Contractors will be selected for implementation of contracts in the following areas:

- supply and installation of flue gas condensers;
- additional measures improving general conditions of the buildings or indoor environment in the buildings.

Tendering for the contracts is expected to begin in Q4 2024 and finish in Q1 2025.

Tendering will be opened to firms from any country, however the proceeds of the grant will not be used for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations or under a law or official regulations of Ukraine.
