**Mobile Off-Grid Solar Power Stations for
Schools #163 and #199 in Kyiv, Ukraine**

This Invitation for Tenders follows the General Procurement Notice dated 24.09.2024 for the project which was published on the Procurement Notices section of NEFCO's website (<https://www.nefco.int>).

Municipal Enterprise “Project Implementation Unit for the Kyiv Public Building Energy Efficiency Project” of the Executive Body of the Kyiv City Council (Kyiv City State Administration), hereinafter referred to as the “Employer,” intends to use part the Government of Norway provided through Norwegian Agency for development cooperation – NORAD and managed by the Nordic Environment Finance Corporation (NEFCO) towards the costs of the project “Procurement, supply and installation of solar off-grid energy solutions in two educational facilities in Kyiv”.

On behalf of the Employer, NEFCO invites Tenderers to submit sealed Tenders for the following contract NO11-2024-185/KYIVPV “Mobile Off-Grid Solar Power Stations for Schools #163 and #199 in Kyiv, Ukraine” for supply of two mobile off-grid solar power stations of 25 kWp, equipped with battery storage systems of 45 kWh to (i) Gymnasium No. 163 at 3 Yanusz Korczak Street, and (ii) Secondary School No. 199 (grades I–III) at 12 Bakynska Street, in Kyiv.

The proceeds of the Grant shall not be used for payment to persons or entities or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under the Chapter VII of the Charter of the United Nations or pursuant to the laws or official regulations of Ukraine.

Tenders and subsequent contracts financed by the grant funds shall be carried out in accordance with NEFCO's Procurement Policy and Procedures.

To be qualified for the award of the contract, tenderers must satisfy the following minimum criteria:

- a) Tenderers shall meet the eligibility requirements set forth in Instruction to Tenderers
- b) Average annual turnover over the last 3 (three) years exceeded: 1,000,000 (one million) Euro. In the case of local currency, the exchange rate prevailing at the end of each fiscal year, as officially published by the National Bank of the Tenderer's country, shall apply;
- c) Demonstrated experience as Supplier, in at least 5 (five) contracts within the last 5 (five) years, each with a value of at least 60,000 (sixty thousand) Euro that have been successfully and substantially completed, delivered and commissioned. They shall be similar in nature and scope of the Equipment and Related Services described in this tender document (Individually, or in case of a JVCA - collectively);
- d) In case of a tender submitted by JVCA, all partners of such a JVCA must jointly meet the qualification criteria, while the leading partner should demonstrate at least 50% compliance with the requirements b) and c) above;
- e) All pending litigations against the Tenderer (including, where applicable partners/members of JVCA) shall not, in total, represent more than 10% of the Tenderer's net worth.

The Employer reserves the right to cancel all tenders in the event of non-approval of grant funding.

All tenders must be accompanied by a Tender-Securing Declaration using the form included in Section III, Tender Forms. The Tender not accompanied by a Tender-Securing Declaration shall be rejected by the Employer as non-responsive and not considered for further evaluation.
