

INVITATION FOR TENDERS TD # NO11-2024-184/NEMPV Ukraine

Mobile Off-Grid Solar Power Station for Wastewater Pumping Station No. 2 in Nemishaeve, Ukraine

This Invitation for Tenders follows the General Procurement Notice dated 24.09.2024 for the project which was published on the Procurement Notices section of NEFCO's website (<https://www.nefco.int>).

Nemishaeve Village Council, hereinafter referred to as “the Employer”, intends to use the part of the proceeds of grant financing from the Government of Norway provided through Norwegian Agency for development cooperation – NORAD and managed by the Nordic Environment Finance Corporation (NEFCO) towards the cost of the project “Procurement, supply and installation of solar off-grid energy solutions for Waste Water Pumping Station No 2”

The Employer now invites sealed tenders from Contractors for the following contract NO11-2024-184/NEMPV “Mobile Off-Grid Solar Power Station for Wastewater Pumping Station No. 2 in Nemishaeve, Ukraine” for supply of a mobile off-grid solar power station of 20 kWp, equipped with battery storage system of 30 kWh.

The proceeds of the Grant shall not be used for payment to persons or entities or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under the Chapter VII of the Charter of the United Nations or pursuant to the laws or official regulations of Ukraine.

Tenders and subsequent contracts financed by the grant funds shall be carried out in accordance with NEFCO's Procurement Policy and Procedures.

To be qualified for the award of the contract, tenderers must satisfy the following minimum criteria:

- a) Tenderers shall meet the eligibility requirements set forth in Instruction to Tenderers
- b) Average annual turnover over the last 3 (three) years exceeded: 1,000,000 (one million) Euro. In the case of local currency, the exchange rate prevailing at the end of each fiscal year, as officially published by the National Bank of the Tenderer's country, shall apply;
- c) Experience as Supplier, in at least 5 (five) contracts within the last 5 (five) years, each with a value of at least 60,000 (sixty thousand) Euro that have been successfully and substantially completed and delivered plant are still in operation as at the time of this tender, and are similar in nature and parameters to the scope of the proposed Equipment and Related Services. (Individually, or in case of a JVCA - collectively):
- d) In case of a tender submitted by JVCA, all partners of such a JVCA must jointly meet the qualification criteria, while the leading partner should demonstrate at least 50% compliance with the requirements b) and c) above
- e) Non-performance of contract by the Tenderer (including partners/members of JVCA if appropriate) did not occur during the last 3 years (2022-2024) based on information provided in Section III, Tender Forms (the Employer reserves the right to check the correctness of the reported information by using other sources);
- f) All pending litigations against the Tenderer (including, where applicable partners/members of JVCA) shall not, in total, represent more than 10% of the Tenderer's net worth

The Employer reserves the right to cancel all tenders in the event of non-approval of grant funding.

All tenders must be accompanied by a Tender-Securing Declaration using the form included in Section III, Tender Forms. The Tender not accompanied by a Tender-Securing Declaration shall be rejected by the Employer as non-responsive and not considered for further evaluation.

Upon receiving the written request from prospective Tenderer, the documents will be promptly dispatched electronically in PDF and MS Word format, however, no liability can be accepted for their non-delivery or late delivery. Tenders must be submitted to NEFCO no later than **10.00 a.m. Kyiv time on 17 November 2025**.
